

WARNING, AGREEMENT TO OBEY INSTRUCTIONS, RELEASE
(Both the applicant student and a parent or guardian must read carefully and sign)

I am aware that soccer, volleyball, basketball, wrestling, and track are stressful sports and that playing or practicing can be a dangerous activity involving MANY RISKS OF INJURY. I understand that the dangers and risks of playing or practicing to play include, but are not limited to death, serious neck or spinal injuries which may result in complete or partial paralysis, brain damage, serious injury to virtually all internal organs, serious injury to virtually all bones, joints, ligaments, muscles, tendons, and other aspects of the muscular skeletal system, and serious injury, or impairment to other aspects of the muscular skeletal system, and serious injury or impairment to other aspects of my body, general health and well being. I understand that the dangers and risks of playing or practicing may result not only in serious injury, but in a serious impairment of my further abilities to earn a living, to engage in other business, social and recreational activities, and generally to enjoy life.

Because of the dangers of all sports, I recognize the importance of following coaches instructions regarding playing techniques, training and other team rules. etc., and to agree to obey such instructions.

That we, the undersigned, for and in consideration of the privilege of our undersigned dependent being able to participate in sports and organized athletic activities at and for Christ The King School year 2____ - 2____, hereby covenant and agree to release and forever discharge Christ The King School, its agents, servants, employees, and volunteer coaches and assistant coaches, Christ The King Parish, its agents, servants, and employees, Christ The King School Council and its members, and the Archdiocese of Kansas City in Kansas, its agents, servants, and employees, from any and all claims, demands losses, damages, costs, expenses, and attorney's fees for injury to or death to the undersigned dependent resulting from, growing out of, caused by, or arising in any manner out of playing or participating in sports or organized athletic activities at and for Christ The King School.

This warning, Agreement to Obey Instructions, and Release is applicable to all sports at Christ The King School.
