Financial Assistance for 2021-2022 School Year

To ensure fair and impartial analysis for families requesting financial assistance for the 2021-2022 school year, Christ the King School is partnering with FACTS Grant & Aid Assessment.

To access the FACTS system, please refer to the information on the back of this page. Applications and supporting documentation must be submitted by March 15, 2021. The goal is for financial aid to be awarded and families notified of their aid amount by early April.

Information contained in the online FACTS application along with supporting documentation is used to determine financial need. The formula utilized has been especially designed for families with children attending private schools. The calculation is based on a moderate standard of living for our geographic area, further ensuring a realistic result. The formula assists in determining the ability of a family to pay for private education. FACTS includes a comprehensive review and verification process ensuring the accuracy of all data received.

Families applying for financial aid will need to complete an online application and submit the necessary supporting documentation to FACTS Grant & Aid Assessment.

- Copy of your most recent Federal income tax forms including all supporting tax schedules.
- Copies of the most recent W-2 forms for the applicant and co-applicant.
- Copies of the 2 most recent pay stubs for the applicant and co-applicant.
- Copies of supporting documentation for Social Security Income, Welfare, Child Support, Food Stamps, Workers' Compensation, etc.
- Documentation of any other information to support the need for financial assistance.

The supporting documentation can be uploaded in PDF format online or faxed to FACTS after the online application is completed.

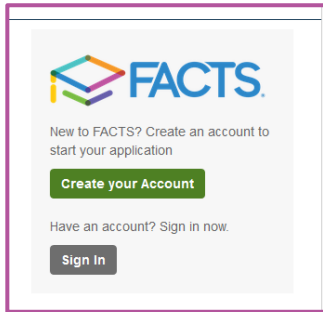
The FACTS Grant & Aid Assessment Application Fee will be \$20.00 for families applying for financial assistance for the 2021-2022 School Year.
